



STATEMENT OF COMMITMENT – FAIR TRADE PRODUCTS

We pledge to our customers that all our products are “Fair Trade Products”
Meaning they were produced and traded under fair conditions, and
Meaning further that

- No child labour is used,
- Above average wages are paid,
- Medical services are provided, and
- Human Rights are observed.

We deal with family-owned businesses where products are made by hand.
These products were designed by WAGNER LIFE DESIGN.

For the past eight years, around 200 workers and their families in Pakistan have earned a living from the production of products for which we place the orders. They have enjoyed good working conditions; they earn wages that are around 20 % above average for comparable work in Pakistan. Should these workers and/ or their families become sick, they receive medical care free of charge. Any worker that gets married will receive two months' wages as a gift. During the past several years, Mr. Wagner travelled to Pakistan on fifteen occasions to continue the design and development of products on site and to experience for himself the favourable working conditions that exist in our production area.

Products made and traded under fair conditions – this does mean somewhat higher prices. We cannot but pass on a portion of the additional costs to our customers asking them to accept the higher costs of our “Fair Trade Products”.
It is a fact that **all** individuals in the chain of production and trade of Fair Trade Products will benefit from such conditions.
We assume that only products made and traded under fair conditions will survive in the market place in the long term.

Five years ago, we established the “SALT HEALTH TRUST” foundation whose objective is the improvement of working conditions of the mine workers in the “Salt Range”, the salt mining region.

Any Euro donated by our customers or by ourselves, benefits these miners directly.

At the present time, we are preparing the construction of a First Aid Station at the mines, which is scheduled to perform regular medical checkups for the mine workers.


It was the SALT HEALTH TRUST charitable foundation that rendered swift, effective direct assistance approximately two years ago after the terrible earthquake devastated Kashmir: To provide shelter from the oncoming winter cold for the homeless, helicopters dropped hundreds of blankets and tent material over the villages in Kashmir that had been cut off. Around one hundred homeless families were able to spend the harsh winter in an old production facility. The following spring, our producer (who is also an architect by trade) led them to construct many new earthquake-proof houses.

The SALT HEALTH TRUST donated the construction materials for this venture.
